# Amending your personal record

You have a right to request appropriate amendments to be made (whether by way of corrections, deletions or additions) to ensure that the personal information held by Council:

- (a) is accurate, and
- (b) having regard to the purpose for which the information was collected (or is to be used) and to any purpose that is directly related to that purpose, is relevant, up to date, complete and not misleading.

If you require access to your personal information you may be requested to show some form of identification to the Council officer. An example is a driver's licence or similar documentation.

If your personal information is amended, you are entitled under the *Privacy and Personal Information Protection Act 1998* ("the Act"), if it is reasonably practicable, to have recipients of that information notified of the amendments made by Council.

## Refusal to process requests

If Council is not prepared to amend the personal information in accordance with a request by you, Council must take such steps as are reasonable to attach to the information in such a manner as is capable of being read with the information, any statement provided by you.

Council may refuse to process your application in part on in whole if:

- (a) there is an exemption to s.15 of the Privacy and Personal Information Protection Act 1998.
- (b) a Code of Practice may restrict alteration
